3. Participants are welcome to bring their own tents and furniture to set up on the site instead of renting them from the rental agency, but only after registration fees are paid. Reservations for rented equipment with spaces must be received **NO LATER THAN JULY 1ST** for the Sycamore Shoals Celtic Festival. All reservations received after deadline will be accepted upon space availability only. **NO Rental equipment will be available after the July 1st deadline** and there is not rental equipment available for any other event so you must furnish your own.
